2016 Amended Felony Bail Schedule

(Including Selected Misdemeanors)

Introduction

Pursuant to Penal Code section 1269b(c), the judges of the Madera County Superior Court hereby adopt this felony bail schedule. The purpose of this schedule is to establish an amount upon which a person arrested without a warrant may be released from custody prior to appearance in court.

At the person's first court appearance, the amount of bail, if any, shall lie within the sound discretion of the judicial officer presiding over that hearing, pursuant to Penal Code section 1269b(b). The bail amount set by said judicial officer may be greater or less than the amount indicated in this schedule, subject to the provisions of Penal Code section 1275.

This felony bail schedule may also be used by a magistrate in establishing bail pursuant to Penal Code section 815a, at the time an arrest warrant is issued, however, the amount of bail remains in the sound discretion of the magistrate.

Total Bail Amount

The total bail for an offense shall be the sum of the amount specifically listed for the offense in this schedule and the amounts listed for all applicable enhancements and prior convictions. If a felony offense is not specifically listed in this schedule, bail should be set according to the following schedule based on the maximum term of incarceration provided for under the law:

If a misdemeanor offense is not specifically listed in this schedule, bail shall be set in the amount of \$5,000.

Bail When Two or More Offenses Charged

Generally, when a person is booked into the Madera County Department of Corrections or charged in a criminal complaint for two or more offenses, bail shall be the amount computed under this schedule for the charge having the highest bail, including all applicable amounts for enhancements and prior convictions. The exception to this general rule is when:

- 1) the offenses are committed against separate victims;
- 2) the offenses are committed on separate dates; or
- 3) where separate sex offenses are committed on the same victim and each offense may be punished separately.

Bail amounts for enhancements and prior convictions shall be added to an aggregate bail amount one time per arrestee, defendant or case.

Applications for Deviation from Bail Schedule

If a person is arrested without a warrant for a bailable felony offense or for a misdemeanor offense involving the violation of a domestic violence restraining order and a peace officer has reasonable cause to believe that the amount of bail provided for in this schedule is insufficient to assure the person's appearance or to assure the protection of a victim of domestic violence, or a family member of such victim, the peace officer shall **prepare a declaration under penalty of perjury** setting forth the facts and circumstances in support of the officer's belief and submit said declaration to the on-call duty magistrate in Madera County.

The duty magistrate to whom the application is made may, in his or her discretion, set bail in an amount that he or she deems sufficient to assure the person's appearance or to assure the protection of a victim of domestic violence or a family member of such victim. The duty magistrate, to whom the application is submitted, may also set bail on the terms and conditions that he or she, in his or her discretion, deems appropriate to assure the person's appearance or to assure the protection of a victim of domestic violence or a family member of such victim.

The peace officer requesting deviation from this bail schedule must submit to the duty magistrate a proposed written order to increase bail along with the officer's declaration in support of his or her application.

When Deviation from Bail Schedule is Not Permitted

Penal Code section 1270.1 prohibits an arrestee from being released on bail in an amount **other than the amount set forth in this bail schedule** prior to a hearing in open court for any of the following violations:

- 1) violent felonies as defined in Penal Code section 667.5(c), with the exception of Penal Code section 460(a);
- 2) serious felonies as defined in Penal Code section 1192.7(c);
- 3) violations of Penal Code sections 136.1(c), 262, 273.5, felony 422 and 646.9; and
- 4) violation of Penal Code section 273.6 if the detained persons made threats to kill or harm, has engaged in violence against or has gone to the residence or workplace of the protected party.

Arrests Alleging Supervision Violations

When a person has been arrested, without a warrant, for an alleged violation of post-conviction supervision, bail shall be set in the following amounts:

- 1) Felony probation No Bail
- 2) Parole No Bail
- 3) Mandatory supervision No Bail
- 4) Post-Release Community Supervision No Bail
- 5) Misdemeanor probation \$10,000 or the bail set forth in this schedule for the underlying offense, whichever is greater

In the event an arrest warrant is issued for an alleged violation of any type of post-conviction supervision, bail shall be set in the amount set forth on the face of the warrant.

Bail in Cases Alleging Prior Convictions for Serious or Violent Felonies

If a person is charged with or arrested without a warrant for a bailable felony offense and it is alleged that the person has suffered one or more prior convictions for a serious felony, as defined in Penal Code section 1192.7(c), or a violent felony, as defined in Penal Code section 667(c), in addition to the bail set for that offense, the following amount shall be added to the aggregate bail amount:

- 1) if one prior serious/violent felony alleged \$50,000
- 2) if two or more serious/violent felonies alleged \$75,000
- 3) if two or more serious/violent felonies alleged and the person is exposed to 25 years to life in prison \$200,000

Bail in Cases Alleging Use or Discharge of a Firearm or Injury Resulting from the Use of a Firearm

If a person is charged with or arrested without a warrant for any felony identified in Penal Code section 12022.53(a) and it is further alleged that the person personally used a firearm, as defined in section 12022.53(b), discharged a firearm, as defined in section 12022.53(c), or personally and intentionally discharged a firearm causing great bodily injury or death, as defined in section 12022.53(d), in addition to the bail set for that offense, the following amount shall be added to the aggregate bail amount:

- 1) for the personal use of a firearm \$100,000
- 2) for the discharge of a firearm \$250,000
- 3) for the personal and intentional discharge of a firearm causing in great bodily injury or death ... \$500,000
