Notice of Intent to Escheat Unclaimed Funds

You are hereby advised that the Superior Court has funds on deposit in the Trial Court Trust account in the amount of \$42,776.41 that have not been claimed for at least three years since the payment was issued or the funds first became eligible for distribution. Under Gov. Code § 68084.1(a) the funds will become the property of the Superior Court if the owner(s) fail to present a claim or file a verified complaint seeking the recovery of the funds by March 31, 2025. The individual amounts and details of the unclaimed property are listed below. If you believe that you, or a person for whom you are a legal guardian or representative, are entitled to all or a portion of the funds held by the Superior Court, you must submit the claim form available on the court's website or file and serve a verified complaint no later than March 31, 2025. The claim form will include the claimant's name, address, amount of claim, and basis for the claim. The claim form must be submitted before the date designated herein.
